**CITY OF KUCHING ORDINANCE, 1988**

*An Ordinance to provide for the establishment of the City of Kuching and for connected and incidental matters.*

*[1st August, 1988]*

Enacted by the Legislature of Sarawak—

**Short title**

1. This Ordinance may be cited as the City of Kuching Ordinance, 1988.

**Interpretation**

2. In this Ordinance—

“City of Kuching North” means the area under the jurisdiction of the Commission;

“City of Kuching South” means the area under the jurisdiction of the Council of the City of Kuching South established under the Local Authorities Ordinance, 1996 [*Cap. 20*];

“Commission” means the Commission of the City of Kuching North or in Bahasa Malaysia “Dewan Bandaraya Kuching Utara” established under the City of Kuching North Ordinance, 1988 [*Cap. 49*].

### City of Kuching

3.—(1) It is established that the area defined in the First Schedule shall, on the date of the coming into force of this Ordinance, become a City and be the Capital of Sarawak and be styled the City of Kuching or in Bahasa Malaysia “Bandaraya Kuching”.

(1A) The Yang di-Pertua Negeri may, by Order in the *Gazette*, amend the First Schedule.

(2) The area of the City of Kuching shall consist of—

(a) the area under the jurisdiction of the Commission to be known as the City of Kuching North; and

(b) the area under the jurisdiction of the Council of the City of Kuching South to be known as the City of Kuching South.

(3) For the purpose of administering the City of Kuching—

(a) the City of Kuching North shall be administered by the Commission which shall exercise all the powers conferred on it by the City of Kuching North Ordinance, 1988 [*Cap. 49*]; and

(b) the City of Kuching South shall be administered by the Council of the City of Kuching South which shall exercise all the powers conferred on it by the Local Authorities Ordinance, 1996 [*Cap. 20*].

(4) Nothing in this Ordinance shall affect the validity or effect of any action, proceeding, conveyance, transfer, deed, transaction or act of any kind *bona fide* taken, entered into or done at any time prior to the coming into force of this Ordinance by or against or in the name or on behalf of the former Kuching Municipal Council or the former Kuching Rural District Council.

*FIRST SCHEDULE*

**LIMITS OF THE CITY OF KUCHING**

(The boundaries of the land described are more particularly delineated on the Land and Survey Department Miscellaneous Plan No. 60371/2, deposited in the office of the Director of Lands and Surveys, Sarawak.)
