THE SARAWAK RIVERS ORDINANCE, 1993

THE SARAWAK RIVERS (FERRY FARES)
REGULATIONS, 2015

(Made under section 38(1)(o))

In exercise of the powers conferred by section 38(1)(o) of the Sarawak Rivers Ordinance, 1993 [*Cap. 4*], the Minister for Infrastructure Development and Communications, with the approval of the Majlis Mesyuarat Kerajaan Negeri, has made the following Regulations:

Citation and commencement

1. This Regulations may be cited as the **Sarawak Rivers (Ferry Fares) Regulations, 2015**, and shall be deemed to have come into force on the 28th day of May, 2015.

Fares chargeable for the ferry users

2. The fares that may be charged for freight or vehicles specified in column (1) of the First Schedule in respect of the use of any ferry provided by Government in Sarawak shall be specified in the column (2), and such fares shall be payable by the driver of the vehicle at the ferry crossing point to the private operator of the ferry.

Exemption

3. Notwithstanding regulation 2, no fare shall be payable in respect of passengers or any of the vehicles specified in the Second Schedule for the use of the ferry.

FIRST SCHEDULE

(Regulation 2)

FARES FOR PASSENGERS OF FREIGHT

No.	(1)	(2)
1.	Car/Mini bus	RM1.00
2.	Bus/Lorry less than 8 tonnes	RM1.00
3.	**Tanker/Lorry weighing 8 tonnes or more	RM5.00
4.	**Tractor/Trailer/Plant	RM10.00

** Permissible Tonnage is subjected to the capacity of the ferries.

SECOND SCHEDULE

(Regulation 3)

EXEMPTED VEHICLES

1. Motorcycles
2. All vehicles belonging to the Federal or State Government including military vehicles and vehicles solely engaged in ambulance duties, fire fighting, police duties or rescue duties (inclusive of rescue teams from the Civil Defence Department).
3. Non-Governmental vehicles solely engaged in ambulance duties.

Revocation

4. The *Gazette* Notification No. *Swk. L.N. 69/2004* dated 8th day of June, 2004, is revoked.
