THE LAND CUSTODY AND DEVELOPMENT AUTHORITY (KJD/LOWER JULAU NCR LAND DEVELOPMENT AREA) (REVOCATION) ORDER, 2023

(Made under section 11(4))

In exercise of the powers conferred upon the Minister by section 11(4) of the Land Custody and Development Authority Ordinance, 1981 *[Ord. No. 4/81]*, the Minister for Natural Resources and Urban Development has made the following Order:

Citation and commencement

1. This Order may be cited as the Land Custody and Development Authority (KJD/Lower Julau NCR Land Development Area) (Revocation) Order, 2023, and shall be deemed to have come into force on the 28th day of May, 2020

Cessation of NCR Land Development Area in Sarikei Division

2. All that area of land described in the Schedule, being the whole of the KJD/Lower Julau NCR Land Development Area as constituted by the Land Custody

and Development Authority (KJD/Lower Julau NCR Land Development Area) Order, 2015 [Swk. L.N. 104/2015], shall cease to be the NCR Land Development Area.

Revocation of Swk. L.N. 104/2015

3. Gazette Notification No. Swk. L.N. 104/2015 dated 26th day of March, 2015, is hereby revoked
