STRATA (SUBSIDIARY TITLES) ORDINANCE, 2019

STRATA (SUBSIDIARY TITLES) (PROCEDURE FOR APPROVAL OF STRATA SUBDIVISION PLAN) RULES, 2022

(Made under section 53)

In exercise of the powers conferred by section 53 of the Strata (Subsidiary Titles) Ordinance, 2019 *[Cap.75]*, the Minister has, with the approval of the Majlis Mesyuarat Kerajaan Negeri makes the following Rules:

Citation and commencement

1. These Rules may be cited as the **Strata** (**Subsidiary Titles**) (**Procedure for Approval of Strata Subdivision Plan**) Rules, 2022, and shall be deemed to have come into force on the 1st day of March, 2022.

Procedure for Strata subdivision plan approval in the case of developments with limited common property

2.—(1) In the case of any development that comprises or is to comprise any limited common property, any submission made under section 6 of the Strata (Subsidiary Titles) Ordinance, 2019 *[Cap. 75]*, for Strata subdivision plan approval shall be accompanied by the following additional information and documents:

- (a) a description of all limited common property comprised or to be comprised in the development;
 - (b) the strata subdivision plan showing the following:
 - (i) the boundaries of the common property and any limited common property comprised within the development; and
 - (ii) all mechanical and electrical services intended for use with that limited common property; and
- (c) a list of all the parcels for whose exclusive benefit the limited common property is to designated in the certified strata plan for that development.
- (2) The strata subdivision plan relating to a development that comprises or is to comprise limited common property need not describe the limited common property if the strata subdivision plan contains information prescribing a way of identifying the limited common property.

Fees

3. The fees payable under the Ordinance or these Rules, as the case may be, shall be as prescribed in the Schedule.
