THE CHARITABLE TRUSTS ORDINANCE, 1994
THE AMANAH KEBAJIKAN MASJID WAN ALWI (TABUAN JAYA)
CHARITABLE TRUST DECLARATION, 2008

(Made under section 3(1))

In exercise of the powers conferred by section 3(1) of the Charitable Trusts Ordinance, 1994 [*Cup. 7*], the Yang di-Pertua Negeri has made the following Declaration:

Citation and commencement

1. This Declaration may be cited as the **Amanah Kebajikan Masjid Wan Alwi (Tabuan Jaya) Charitable Trust Declaration, 2008**, and shall come into force on 1st day of September, 2008.

Declaration of Charitable Trust

2. It is declared that—

(a) a Charitable Trust shall be created and be known as the Amanah Kebajikan Masjid Wan Alwi (Tabuan Java) Charitable Trust;

(b) the properties described in the First Schedule shall be administered by a Board of Trustees appointed under section 4 of the Charitable Trusts Ordinance, 1994 [Cap. 7];

(c) the beneficiaries of the Amanah Kebajikan Masjid Wan Alwi (Tabuan Jaya) Charitable Trust shall be the members of the Malay community in and for the State of Sarawak; and

(d) the purposes of the Amanah Kebajikan Masjid Wan Alwi (Tabuan Jaya) Charitable Trust are as set out in the Second Schedule.

FIRST SCHEDULE

(Paragraph 2(b))

TRUST PROPERTIES

1. Land, buildings, infrastructures and any other property owned by or to be acquired by the Amanah Kebajikan Masjid Wan Alwi (Tabuan Jaya) Charitable Trust.
2. Contributions, donations and gifts from any sources for purposes that Charitable Trust.
3. Masjid Wan Alwi, Jalan Bayor Bukit, Tabuan Jaya, 93350 Kuching, Sarawak

SECOND SCHEDULE

(Paragraph 2(d))

TRUST PURPOSES

1. The dissemination of the religion of Islam and education of the Muslim community in the Kuching District.
2. The provision, maintenance and improvement of suraus, and other educational buildings and infrastructures including land for burial grounds for that community.
3. The relief of poverty among persons within in the Malay community, and for any other charitable purposes.
