(Made under section 37(1))

In exercise of the powers conferred by section 37(1) of the National Parks and Nature Reserves Ordinance, 1998 *[Cap. 27]*, the Majlis Mesyuarat Kerajaan Negeri has made the following Regulations:

PART I

PRELIMINARY

Citation and commencement

1. These Regulations may be cited as the **National Parks and Nature Reserves Regulations, 1999**, and shall come into force on the 1st day of January, 2000.

Interpretation

2. In these Regulations—

“adventure caving” means walking and climbing in areas which are largely in their natural state having no or very little basic facilities and which requires physical challenges to reach the destination;

“adventure trekking” means taking part in caving activity at areas which are largely in their natural state having no or very little basic facilities and which requires physical challenges to reach the destination;

“cave” means a natural cavity on the ground large enough for human passage;

“children” shall have the same meaning as in the Child Act 2001 *[Act 611]*;

“commercial filming and photography” means any filming or photography principally intended for public viewing and financial gain; commercial filming includes advertisements, feature films, TV drama, documentaries, educational films and non-government sponsored filming and tourism promotions; commercial photography includes images for magazines, postcards, promotional of private events or products;

“DAN” means Divers Alert Network, an international organization for SCUBA divers safety and emergency procedures;

“disabled person” shall have the same meaning as in the Persons With Disabilities Act 2008 [Act 685];

“FLOAT” means the activity plan for diving vessels which includes times and locations;

“historical site” has the meaning assigned thereto by the Sarawak Cultural Heritage Ordinance, 1993 [Cap. 6];

“leisure trekking” means walking in areas which have basic facilities provided and this does not require physical challenges to reach the destination;

“local community” means any community residing within the boundaries of a national park or a nature reserve or in the vicinity thereof;

“locals” means Malaysians and includes persons who are permanent residents in Sarawak;

“managing agent” means any person or company appointed pursuant to section 25(1) of the Ordinance, to build, manage or maintain any building and facilities in a national park or nature reserve or a historical site or monument therein or to undertake the provision of service therein, and includes his servant, workmen or agent;

“mermaid line” means a length of floating rope attached to a stationary boat and which is used as a safety line by SCUBA divers;

“motorized equipment” means any equipment with a motor, and includes vehicles, outboard engines, generators, grass cutters, aircrafts, jet skis, paragliding apparatus and others;

“NAUI” means National Association of Underwater Instructors, a non-profit making international organization for SCUBA diving education;

“Ordinance” means the National Parks and Nature Reserves Ordinance, 1998 [*Cap. 27*];

“park guide” means any person licensed by the Controller under regulation 8, to guide visitors in a national park or nature reserve;

“SCUBA” means self-contained underwater breathing apparatus used in underwater diving;

“SCUBA diver” means a person who dives underwater using a self-contained underwater breathing apparatus;

“senior citizen” means a Malaysian who is 60 years old and above;

“show cave” means any cave or part of a cave with man-made walkways or facilities and lighting from a fixed and non-natural source;

“skin diver” means a person who dives underwater without using a self-contained underwater breathing apparatus;

“subsisting rights and privileges” means those rights and privileges admitted at the time of the constitution of a national park or a nature reserve;

“turtle beach” means any area of the foreshore designated by the Controller for sea turtles or painted terrapins to land and nest;

“turtle beach zone” includes the turtle beach and all areas within twenty metres of the landward side and seaward side thereof;

“visitor” means any person entering or visiting a national park or nature reserve for whatever reason, including for the discharge of any official functions or duties, for diving or for the exercise of any subsisting rights or privileges, and also includes a park guide or a managing agent;

“wild cave” means any cave or part of a cave other than a show cave, where visitors are permitted by the Controller under regulation 27;

“World Heritage Site” has the same meaning as that given by the World Heritage Convention.

PART II
ENTRY INTO NATIONAL PARKS AND
NATURE RESERVES

Fees and charges

3.—(1) Subject to regulations 5 and 6, any person may enter a national park or nature reserve upon payment of the entrance fees and other charges prescribed in the Second Schedule.

(2) Notwithstanding paragraph (1), the Controller may waive or reduce the entrance fees for any person or class of person.

(3) Notwithstanding paragraphs (1) and (2), the Controller may at his discretion, waive or vary the accommodation charges, park guiding fees and other related fees and charges prescribed in the Second Schedule.

Park ticket

4.—(1) Any person who has paid the entrance fee shall be issued with a park ticket as evidence of the payment thereof, and of permission to enter the national park or nature reserve in respect of which the ticket is issued. The conditions of entry shall be stated on the park ticket.

(2) The holder of such a park ticket shall produce the same on demand by a Park Warden or any person duly authorized by him to demand the same, for his inspection.

(3) Subject to regulation 3(2), any person who, on demand, is unable to produce a park ticket for inspection, shall be deemed to have entered the national park or nature reserve without permission or in contravention of regulation 3(1), and may be removed or evicted from the national park or nature reserve.

Special permission

5.—(1) Any person who wishes to enter a national park or nature reserve for the purpose of—

(a) carrying out any research on any biological materials, animals or insects therein, whether or not pursuant to any written law; or

(b) conducting or organising any expedition, whether for sporting events, exploration, adventure, study or scientific purposes; or

(c) carrying out the filming or the production of any audio-visual presentation, whether for commercial or educational purposes; or

(d) organising or presenting any show, performance, display or exhibition or conducting any course, seminar or meeting,

must first obtain a permit from the Controller for any such purposes, in the form prescribed in the First Schedule.

(2) Nothing in this regulation shall be construed as a waiver of a permit holder from payment of the entrance fees prescribed in the Second Schedule.

Denial of entry of person into a national park or nature reserve

6. A Park Warden may refuse entry to a national park or nature reserve by any person whom he has reason to believe—

(a) has previously committed an offence under the Ordinance or the Wild Life Protection Ordinance, 1998 [*Cap. 26*], or the Forests Ordinance [*Cap. 126 (1958 Ed.)*] or is likely to commit such offence if he were to be permitted entry thereto; or

(b) is intoxicated or is under the influence of drugs or alcohol; or

(c) is likely to damage or cause damage to any property, biological materials, animals, historical monuments or sites within the national park or nature reserve; or

(d) wishes to undertake any of the activities described in regulation 5, but does not possess the requisite permit from the Controller; or

(e) if he is a managing agent or a park guide, his agreement made under section 25(2) of the Ordinance or his licence has been terminated, revoked or cancelled; or

(f) is bringing in motorized equipment without the permission from the Controller or Chief Park Warden.

Visitors to be accompanied by park guide

7.—(1) A Park Warden may require visitors to a national park or nature reserve or part thereof to be accompanied by a park guide.

(2) Guiding fees shall be paid for the service of a park guide who is the employee of the park management authority in accordance with the rates specified in the Second Schedule.

Park guide to be licensed

8.—(1) A park guide must possess a licence issued by the Controller to provide guiding services in a national park or nature reserve. The licence shall be in Form C of the Third Schedule.

(2) No licence for a park guide shall be issued unless the Controller is satisfied that the person applying for such licence has undergone and successfully completed such courses or training as may be prescribed or approved by the Controller, and that he is a person of good character, physically and medically fit to perform the duties of a park guide.

(3) A licence issued under this regulation shall be for a period not exceeding three years and may be renewed at the discretion of the Controller.

(4) The Controller may revoke a licence if he is satisfied that—

(a) the park guide has breached any of the terms and conditions of the licence;

(b) the park guide is guilty of any misconduct in relation to the performance of his duties;

(c) the park guide is suffering from any disease, illness or physical infirmity as to render himself unable or unsuitable to carry out the duties as a park guide; or

(d) for such other reasons, which in the opinion of the Controller, is detrimental to the national park or nature reserve for the guide to continue to operate therein.

Expulsion of person from a national park or nature reserve

9. Any person who contravenes, or where the park officer has reasons to believe that he would contravene, the provisions of the Ordinance or these Regulations, may be expelled from the national park or nature reserve by the Park Warden or any park officer authorized by him, and all expenses arising from such expulsion shall be borne by the person so expelled, and all fees paid shall not be refundable.

Exemption from liability

10. Neither the Government nor the Controller nor a Park Warden shall be liable for any accident or injury or damage or loss caused to or suffered by any visitor in a national park or nature reserve or for any act, omission, default or negligence of a park guide who shall be deemed to be an agent of the visitor.

Exercise of subsisting right or privilege

11.—(1) Any person exercising any subsisting rights or privileges within a national park or nature reserve shall comply with the direction and order of the Park Warden, and shall exercise such rights or privileges within such places as may be designated by the Controller.

(2) Any person who fails to comply with the requirements of paragraph (1) may be required by the Park Warden to leave the national park or nature reserve and the exercise of such rights or privileges by him may be suspended by the Controller for such period as the Controller may deem fit.

(3) Any person who exercises or attempts to exercise any subsisting rights or privileges whilst the exercise thereof by him is suspended by the Controller under paragraph (2) shall be guilty of an offence: Penalty, a fine not exceeding three thousand ringgit or imprisonment not exceeding six months or both fine and imprisonment.

PART III

MANAGEMENT OF SPECIFIC AREAS

A. Aquatic Areas

Aquatic areas

12. Where a national park or nature reserve covers the inland water areas or territorial waters of the State (hereinafter referred to as “aquatic areas”), no diving, whether for pleasure, recreation, exploration or undertaking scientific or underwater studies or research, may be carried out without the permission of a Park Warden.

Supervision and guidance by park guide

13. No diving shall be permitted in aquatic areas unless the diver is supervised and guided by a park guide.

Permitted hours for diving

14. Diving shall only be permitted between the hours of 8.00 a.m. and 6.00 p.m. each day but no diving would be permitted during inclement weather or dangerous sea conditions.

Requirements for SCUBA diving

- 15.—(1) All SCUBA divers in aquatic areas must—
- (a) possess a current diver certification by a recognized SCUBA instructional agency;
 - (b) lodge a FLOAT plan with the office of the Park Warden;
 - (c) dive only within areas designated by the Controller for SCUBA diving;
 - (d) abide by NAUI Safe Diving Practices Code or equivalent standards of safety practices; and
 - (e) not touch or disturb any marine creature or underwater formation or intentionally move within five metres of a turtle.
- (2) All SCUBA divers shall comply with all other directions, instructions or orders issued by the Controller or a Park Warden.

Requirements for skin-diving

- 16.—(1) All skin divers in aquatic areas shall not—
- (a) touch or disturb any marine creature or underwater formations or intentionally move within five metres of a turtle; or
 - (b) stand on a coral reef or any part thereof.
- (2) All skin divers shall comply with all other directions, instructions or orders from the Controller or a Park Warden.

Vessels for diving

- 17.—(1) Vessels used for SCUBA or skin diving shall not enter or remain in aquatic areas of any national park or nature reserve without the prior permission of a Park Warden.
- (2) No permission shall be given by a Park Warden unless he is satisfied that—
- (a) the vessel possesses the requisite certificate of registration and seaworthiness issued by the Department of Marine;

(b) there is on board the vessel a person suitably qualified in administering first aid, cardio-pulmonary resuscitation and oxygen resuscitation procedures;

(c) the vessel has on board facilities and medical supplies for treatment of injuries commonly sustained by divers; and

(d) the vessel is equipped with adequate or proper telecommunications equipment, an alpha flag for SCUBA diving and a mermaid line.

Anchorage of vessels

18. No vessel shall anchor in aquatic areas within a national park or nature reserve except at such places as may be designated by the Controller for anchorage or berthing of vessels.

B. Turtle Beach

Entry into a turtle beach zone

19. No person shall between the hours of 6.00 p.m. and 8.00 a.m. on the following day enter a turtle beach zone without the permission of the Park Warden.

Vessels in a turtle beach zone

20. No vessel, except—

(a) in the case of emergency; or

(b) where prior permission is granted by the Park Warden,

shall enter, ply along or leave the areas within the boundaries of a turtle beach zone between the hours of 6.00 p.m. and 8.00 a.m. on the following day.

Restriction of activities in a turtle beach zone

21. No person shall, in a turtle beach zone,—

(a) touch, disturb or injure any turtle;

(b) disturb any turtle nests;

(c) sit or ride on a turtle; or

(d) create or cause any nuisance which would drive turtles away from the turtle beach.

Lighting

22. No person shall shine or focus any lights, whether from land or any vessel, on a turtle beach zone.

C. Caves

Entry to caves

23.—(1) The Controller shall determine the times, terms and conditions whereby visitors may be permitted to enter, visit and remain in any cave within a national park or nature reserve and may restrict the number of visitors entering or remaining in such cave.

(2) The Park Warden may, in the event of inclement weather or circumstances which render the conditions within a cave dangerous for visitors to enter or remain therein, direct or order the cave to be closed to visitors for such period as he deems fit.

Restrictions on persons

24. No person entering a cave shall bring with him any umbrella, walking stick, tripod or other similar objects as stipulated by the Controller by notice posted outside the cave.

Special restrictions on persons

25.—(1) No person shall in any cave—

(a) collect guano or bird nests; or

(b) undertake any scientific research on the biological resources or wild life therein,

except in accordance with a permit or licence issued under any relevant written law.

(2) Notwithstanding paragraph (1), any person having a permit or licence with regard thereto, shall, when in a cave, comply with these Regulations and any order or direction of a Park Warden.

Prohibited activities of visitors

26. A visitor to a show cave shall—

(a) not damage, deface, alter or touch any geological formation inside the show cave;

- (b) keep to and remain on the walkways at all times;
- (c) not smoke, eat or drink, or supply food to or feed any animals or insects therein;
- (d) not litter or deposit any rubbish, refuse or waste, except in such bins or receptacles provided by the Park Warden for such purpose;
- (e) comply with all instructions, orders or directions given by a Park Warden; and
- (f) be accompanied by a park guide.

Entry to wild cave

27. The Controller may designate any cave or part thereof, other than a show cave, as a wild cave whereby visitors may be permitted entry to see, appreciate or study its geological formation, beauty, archaeological features and the flora and fauna therein.

Instructions, orders or directions

28. Any visitor to a wild cave must be accompanied by a park guide and must comply with all instructions, orders or directions of the Park Warden and the park guide.

Eviction

29. A Park Warden may evict or require any visitor who contravenes any of the provisions of these Regulations to forthwith leave a show cave or wild cave.

D. Historical Sites

Duty of Controller to protect historical sites, etc.

30. The Controller shall, in consultation with the Director of Sarawak Museum, take all necessary measures to protect, preserve and maintain all historical sites and historical monuments which are situated within a national park or nature reserve.

Prohibited activities in historical site

31. No alteration, excavation, removal or demolition of any historical monument or site within a national park or nature reserve shall be carried out without the prior written approval of the Director of Sarawak Museum and except in accordance with the Sarawak Cultural Heritage Ordinance, 1993 [Cap. 6].

Designation of historical site

32. The Controller may make recommendations to the Director of Sarawak Museum to designate any area within a national park or nature reserve as a historical site under the Sarawak Cultural Heritage Ordinance, 1993 [*Cap. 6*].

Special area

33.—(1) Where the Controller is satisfied that any area or site within a national park or nature reserve, which has not been declared a historical site under the Sarawak Cultural Heritage Ordinance, 1993 [*Cap. 6*], shall be preserved or protected because of its cultural, traditional or archaeological value or significance, he may, after consultation with the Special Parks Committee, by order signed by him, designate such area or site as a special area.

(2) The Park Warden shall maintain the special area subject to such directions as may be given from time to time by the Controller.

(3) The order made by the Controller under paragraph (1) shall be posted or exhibited at the special area and at a conspicuous part of the national park or nature reserve.

PART IV

MISCELLANEOUS

General fees

34. The Controller may, in addition to the entrance fees chargeable under regulation 3, impose such fees as may be prescribed by him, for the entry into any cave, or special area designated under regulation 33, or to any other areas or places, or for any activity or function or event organized or arranged by the Controller or with his approval.

Rent

35. Where land or any area of land within a national park or nature reserve is used for the siting of any pole, tower or any other similar structure for electricity or telecommunication transmission or for the location of pipe lines for the conveyance of electricity or gas, the Controller shall, in consultation with the Minister, impose such fees, rent or charges on the use of such land, to be paid by the owner or person responsible for such structures or pipe lines.

Non-transferability of permits, licences, etc.

36. Permits and licenses issued under these Regulations shall be personal to the holders thereof and shall not be transferable without the prior permission of the Controller.

General penalty

37. Any person who contravenes or fails to comply with any of the provisions of these Regulations, or any condition of a permit or license issued or any order or directions issued by the Controller or a Park Warden under these Regulations, shall be guilty of an offence and shall, if no penalty is expressly provided for the said offence in the Ordinance or these Regulations, be liable to a fine not exceeding three thousand ringgit and, in the case of a continuing offence, to a further fine not exceeding five hundred ringgit for each day during which the offence continues.

Requirement, direction, order or permission

38. Except as otherwise provided in these Regulations, any requirement, direction, order or permission by the Controller, under or for the purpose of these Regulations, may be made or given by notice in writing.

Compensation for damages to property and natural environment

39. Any person found responsible for any form of damage to property or to the natural environment within a national park or nature reserve, including damages due to acts of negligence or accident, shall be liable to pay compensation in the quantum and form as may be determined by the Controller.

Prohibition as to fire

40.—(1) No person shall kindle, keep or carry any fire or leave any fire burning near a national park or nature reserve in such manner as to endanger such national park or nature reserve.

(2) Whoever does any act in contravention of paragraph (1) shall be guilty of an offence: Penalty, a fine not exceeding five thousand ringgit or imprisonment not exceeding one year or both fine and imprisonment.

Cancellation or withdrawal of permit, licence or permission

41. The Controller may cancel, withdraw or terminate any agreement made, permit or licence issued or permission granted under these Regulations in the event that—

- (a) there has been a breach of any term or condition of any agreement made under section 25(2) of the Ordinance, or of any condition imposed in any permit, licence or guidelines issued by the Controller under these Regulations, or of any of the provisions of the Ordinance or these Regulations; or

- (b) the fees chargeable thereunder have not been paid.

Closure of public facility, etc., due to degradation

42.—(1) The Controller or a Chief Park Warden may, acting upon the advice of a Park Warden or a Special Park Committee that there has been severe damage to any part of any public facilities or utilities or severe environmental degradation to any part or area of a national park or nature reserve, order the closure of the affected public facilities or utilities, part or area thereof for such period as the Controller may direct.

(2) During the closure of such facilities or utilities, part or area of the national park or nature reserve, the Controller shall notify the general public as soon as possible of the closure.

Appeal

43. Any person who is aggrieved by the decision of the Controller either not to grant an entry permit or not to extend such permit or to deny their entrance, may appeal to the Minister whose decision shall be final and shall not be questioned or reviewed in any court.

Code of ethics and other acts prohibited in a national park or nature reserve

44.—(1) All persons, whilst within a national park or nature reserve, shall observe and maintain a decent code of ethics and shall not—

- (a) gamble; or
- (b) become intoxicated by alcohol or any form of drug; or
- (c) litter or deposit any rubbish, refuse or waste, except in such bins or receptacles provided by the Park Warden for such purpose; or
- (d) create any nuisance; or
- (e) conduct themselves indecently, or behave in a rude or unruly or aggressive manner; or
- (f) without approval of the Park Warden, sell or offer for sale any food, goods or articles, or exhibit or conduct any exhibition; or
- (g) beg or solicit for alms.

(2) Any person who commits any of the acts set out in paragraph (1) may be removed or evicted forthwith from the national park or nature reserve by the Park Warden.

Deposit to be paid by holder of permit or licence

45. The Controller may require a deposit to be paid to him by the holder of any permit or licence issued under these Regulations, the amount to be determined by him and which shall be refundable upon expiry of the permit or licence where there is no non-compliance by the holder of the terms and conditions thereof.

Visitors to take out their rubbish from the national park or nature reserve

46. All visitors to a national park or nature reserve shall, upon leaving the national park or nature reserve, take out with them all carcasses, papers, boxes, bottles, tins, refuse, waste, noxious liquid or other offensive or filthy matter of any kind, produced, generated or brought in by them.

Responsibility of managing agent

47. A managing agent shall be responsible at all times for the conduct, activities, acts and omission of any of his employees, workmen, servants, or agents whilst they are in the national park or nature reserve, and shall ensure that they observe and comply with the Ordinance and these Regulations.

Compoundable offences

48. The following offences may be compounded by the Controller or any park officer specially authorized in writing in that behalf by the Controller, namely —

- (a) all offences under the Ordinance; and
- (b) all offences under any regulations made pursuant to section 37(1) of the Ordinance.

Offer to compound

49.—(1) Where the Controller or any duly authorized officer decides to compound an offence, he shall send or cause to be sent to or personally serve or cause to be personally served on the person reasonably suspected of having committed the offence, an offer to compound as in Form A in the Third Schedule, which may be modified as necessary.

(2) The offer shall state the sum for which the offence will be compounded and the date by which the sum must be paid.

Sum to be collected and mode of payment

50.—(1) The sum of money to be collected for compounding an offence shall not exceed one half of the maximum fine prescribed for the offence.

(2) All monies for payment of the compound shall be made in cash, money order, postal order, cashier's order, bank order or bank draft made payable to the "Government of Sarawak" and crossed "Account Payee Only".

(3) Payment may be delivered personally to the officer making the offer to compound but, if sent by post, must be addressed to the Controller or Chief Park Warden, together with the form for payment as in Form B in the Third Schedule, or at such other place as may be specified by the Controller.

(4) Every payment received shall be accounted for as money belonging to the Government and an official receipt shall be issued for the payment.

(5) Notwithstanding regulation 49(2), although the date for payment has lapsed, the officer making the offer to compound as in Form A in the Third Schedule may, nevertheless, accept in payment of the compound the amount stated therein.

Revocation

51. The National Parks (Fees) Regulations, 1994 [*Swk. L.N. 49/94*], are revoked.
