# THE SARAWAK RIVERS (KUALA RAJANG ANCHORAGE AREA) NOTIFICATION, 1996

[Swk. L.N. 72/96]

(Made under regulation 18)

Pursuant to regulation 18 of the **Sarawak Rivers (Traffic) Regulations, 1993** [Swk. L.N. 130/93], the Controller of Rivers has made the following Notification:

#### Citation and commencement

1. This Notification may be cited as the Sarawak Rivers (Kuala Rajang Anchorage Area) Notification, 1996, and shall come into force on the 1st day of January, 1997.

#### Interpretation

2. In this Notification—

"Principal Regulations" means the Sarawak Rivers (Traffic) Regulations, 1993 [Swk. L.N. 130/93].

#### Kuala Rajang anchorage area

- 3.—(1) The Controller of Rivers has designated that the area described in the First Schedule shall be anchorage area for vessels and river rafts to load or unload round logs, sawn timber, coal and other cargoes. A map showing the position of the anchorage area is set out in the Second Schedule.
- (2) No person shall anchor, moor or berth any vessel or river raft in Tanjong Manis or in any area in Kuala Rajang outside the anchorage area for the purpose of loading or unloading round logs, sawn timber, coal and other cargoes, save under the circumstances and conditions specified in regulation 18(2) of the Principal Regulations.
- (3) The master of every vessel when at anchor in the designated anchorage area described in the First Schedule shall—
  - (a) notify the Controller of the quantity and type of cargoes to be loaded or discharged;
  - (b) notify the Controller of Rivers or his authorized representatives of the time and date of arrival and departure of the vessels;
  - (c) pay such fees as are prescribed in Part II of the Second Schedule to the Principal Regulations;

- (d) comply with the provisions of regulation 18(3)(a) and (c) of the Principal Regulations; and
- (e) comply with any requests made by the Controller of Rivers, or any direction issued by the Board, under regulation 24 of the Principal Regulations.
- (4) Any person who contravenes or fails to comply with any of the provisions of regulation 18 or 24 of the Principal Regulation (as indicated in paragraph 3 of this Notification) shall be liable to the penalty imposed under regulation 66 of the Principal Regulations.


