

THE STATE ROADS ORDINANCE, 1994  
THE STATE ROADS (UPPER LANANG BRIDGE) (TOLLS) ORDER, 2006  
[Swk. L.N. 33/2006]

(Made under section 6(2))

In exercise of the powers conferred by section 6(2) of the State Roads Ordinance, 1994 [Cap. 9], the Director of Public Works has, with the approval of the Minister of Infrastructure Development and Communications, made the following Order:

**Citation and commencement**

1. This Order may be cited as the **State Roads (Upper Lanang Bridge) (Tolls) Order, 2006**, and shall come into force on the 24th day of April, 2006.

**Authority to collect toll**

2. As from this date, Woodville Development Sdn. Bhd. (Co. No. 284646-A) with a registered address at No. 126, 2nd Floor, Jalan Bendahara, 98000 Miri, Sarawak ("Woodville") may collect from vehicles of the class and description referred to in the first column of the Schedule, crossing or using the Upper Lanang Bridge at Batang Rajang, Sibu Division ("the Bridge"), tolls specified in the second column, and Woodville shall be entitled to retain all tolls so collected.

**Liability for toll**

3. It shall be the responsibility of the drivers to pay to Woodville the tolls chargeable under this Order on their vehicles.

**Place where tolls are to be collected**

4. Woodville shall collect such tolls at place(s) on the access roads to the Bridge designated by the Director.

**Exemptions**

5. The following shall be exempted from the payment of any tolls when crossing or using the Bridge:

(a) all pedestrians and passengers of vehicles, non-mechanical vehicles, ambulances and vehicles belonging to the Royal Malaysia Police, Civil Defence and Fire and Rescue Services; and

(b) any other vehicles specifically exempted by Woodville, with the approval of the Minister.

Tankers/Trucks 10 tons above - 20 tons	RM20.00
Tankers/Trucks 20 tons above and trailers	RM25.00
