THE PORT AUTHORITIES ORDINANCE, 1961

SAMALAJU PORT AUTHORITY

(APPOINTMENT OF APPROVED PORT OPERATOR) NOTIFICATION, 2015

(Made under section 12(2)(a))

In exercise of the powers conferred by section 12(2)(a) of the Port Authorities Ordinance, 1961 [*Ord. No. 1/61*] (“the Ordinance”), the Samalaju Port Authority, with the approval of the Majlis Mesyuarat Kerajaan Negeri, has made the following Notification:

**Citation and commencement**

1. This Notification may be cited as the **Samalaju Port Authority (Appointment of Approved Port Operator) Notification, 2015**, and shall be deemed to have come into force on the 7th day of July, 2011.

**Appointment of approved port operator**

2. Samalaju Port Authority has, with the approval of the Majlis Mesyuarat Kerajaan Negeri, appointed SAMALAJU INDUSTRIAL PORT SDN. BHD. (Co. No. 406345-H) formerly known as BPSB Management Sendirian Berhad, a company incorporated in Malaysia under the Companies Act 1965 [*Act 125*] and

having its registered office at Lot 15, Block 20, Kemena Land District, 12th Mile, Tanjung Kidurong Road, 97008 Bintulu, Sarawak, Malaysia (“the Company”) a wholly-owned subsidiary of Bintulu Port Holding Berhad as an approved port operator.

**Duration of appointment**

3. The appointment shall be deemed to have commenced from the 7th day of July, 2011 for such period as stated in the Agreement specified in paragraph 4 below.

**Terms and Conditions**

4. The terms and conditions for the appointment of the Company as an approved port operator are as set out in the Agreement entered into between Samalaju Port Authority and the Company on the 9th day of July, 2013 pursuant to section 12(2)(a) of the Ordinance.

**Port undertakings**

5. The Company as approved port operator shall provide the following undertakings:

(a) Exclusive rights to build the port facilities according to the Development Plan for the port and to operate, manage, maintain and provide port facilities and services of port undertakings described in Annexure C and G of Principal Agreement between the State Government of Sarawak and Bintulu Port Holding Berhad and Samalaju Industrial Port Sdn Bhd.

(b) Measures and facilities to protect and secure the said cargoes from all hazards and risks of whatsoever nature.

(c) Such others services or undertaking in relation to the said types of cargoes as may be agreed from time to time between Samalaju Port Authority and the Company.
