#### THE FORESTS ORDINANCE, 2015

THE FORESTS (FOREST CARBON ACTIVITY) (AMENDMENT) RULES, 2025

(Made under section 113(1)(bb))

In exercise of the powers conferred by section 113(1)(bb) of the Forests Ordinance, 2015 *[Cap. 71]*, read together with rule 41(3) of the Forests (Forest Carbon Activity) Rules, 2022 *[Swk. L.N. 350/2022]*, the Minister, with the approval of the Majlis Mesyuarat Kerajaan Negeri, has made the following Rules:

#### Citation and commencement

1. These Rules may be cited as the Forests (Forest Carbon Activity) (Amendment) Rules, 2025, and shall be deemed to have come into force on the 1st day of March, 2025.

#### **Amendment to the Fourth Schedule**

**2.** The Fourth Schedule to the Forests (Forest Carbon Activity) Rules, 2022 *[Swk. L.N. 350/2022]* (the "Principal Rules") is amended by substituting the Fourth Schedule with the following new Fourth Schedule—
