THE CHARITABLE TRUSTS ORDINANCE, 1994

THE YAYASAN WAKAF SARAWAK CHARITABLE TRUST  
DECLARATION, 2025

(Made under section 3(1))

In exercise of the powers conferred by section 3(1) of the Charitable Trusts Ordinance, 1994 [*Cap. 7*], the Yang di-Pertua Negeri has made the following Declaration:

**Citation and Commencement**

1. This Declaration may be cited as the **Yayasan Wakaf Sarawak Charitable Trust Declaration, 2025**, and shall be deemed to have come into force on the 1st day of January, 2025.

**Declaration of Charitable Trust**

2. It is hereby declared that—

(a) a Charitable Trust shall be created and be known as the Yayasan Wakaf Sarawak Charitable Trust;

(b) the trust properties described in the First Schedule shall be administered by a Board of Trustees appointed under section 4 of the Charitable Trusts Ordinance, 1994 [*Cap. 7*];

(c) the beneficiaries of the Yayasan Wakaf Sarawak Charitable Trust shall be the Majlis Islam Sarawak and the members of the Muslim community in Sarawak; and

(d) the purposes of the Yayasan Wakaf Sarawak Charitable Trust are as set out in the Second Schedule.

*FIRST SCHEDULE*

(Paragraph 2(b))

TRUST PROPERTIES

- (1) Wakaf properties and assets.
- (2) Funds which have been or shall be donated, collected or pledged for the Charitable Trust purposes stipulated under the Second Schedule.
- (3) Contributions, donations and gifts from Government, any institutions, corporations and any other persons or individuals or sources for purposes of the Charitable Trust, including any legacies and properties bequeathed by will or other instruments for the Charitable Trust purposes set out under the Second Schedule.
- (4) Land, building and other properties or assets, movable and immovable, including moneys, bonds and shares acquired or held or controlled for the purposes of the Charitable Trust.

*SECOND SCHEDULE*

(Paragraph 2(d))

TRUST PURPOSES

- (1) The support, promotion and advancement of Islamic religion and education among the Muslim community in Sarawak in accordance with the Majlis Islam Sarawak Ordinance, 2001 [*Cap. 41*].
- (2) The provision, maintenance and improvement of lands, buildings and infrastructures including mosques, suraus, burial grounds, educational and any religious purposes for the benefit the Muslim Community in Sarawak.
- (3) The relief of poverty among the Muslim Community in Sarawak.
- (4) Any other religious or charitable purposes which will be for the benefit of the indigenous Muslim community of Sarawak.

All the above purposes shall be carried out in accordance with the direction of the Majlis Islam Sarawak from time to time.
