THE STATUTORY BODIES (FINANCIAL AND ACCOUNTING PROCEDURE)
(AMENDMENT TO SCHEDULE) ORDER, 2024

In exercise of the powers conferred by section 19 of the Statutory Bodies (Financial and Accounting Procedures) Ordinance, 1995 [*Cap. 15*], (“the Principal Ordinance”), the Premier has made the following Order:

Citation and commencement
