THE PUBLIC PARKS AND GREENS ORDINANCE, 1993

THE PUBLIC PARKS AND GREENS (DESIGNATION OF MANAGEMENT AGENCY)  
NOTIFICATION, 2020

(Made under section 3(3)(a))

In exercise of the powers conferred by section 3(3)(a) of the Public Parks and Greens Ordinance, 1993 [*Cap. 3*], (“the said Ordinance”), the Chief Minister has made the following Notification;

**Citation and commencement**

1. This Notification may be cited as the **Public Parks and Greens (Designation of Management Agency) Notification, 2020**, and shall be deemed to have come into force on the 1st day of January, 2020.

**Designation of Management Agency**

2. The Commission of the City of Kuching North (DBKU), a body corporate established under the City of Kuching North Ordinance, 1988 [*Cap. 49*] and having its address at Bukit Siol, Jalan Semariang, Petra Jaya, 93050, Kuching, Sarawak, is hereby designated and appointed as the Management Agency to manage, maintain, administer and exercise control over the Special Areas described

under Item 4 (Kuching Waterfront) in the Schedule to The Public Parks and Greens (Special Areas) (No.1) Notification, 1995 [*Swk. L.N. 67/1995*].

**Functions and Powers of Management Agency**

3. (a) The Commission of the City of Kuching North, as the Management Agency, shall exercise the functions and powers stipulated in section 4 of the said Ordinance; and

(b) In the exercise or discharge of its functions and powers as the Management Agency, the Commission shall be entitled to—

(i) enter into agreement for the use of any facility owned or provided by the Commission within the Special Areas;

(ii) levy, collect, recover, retain and account for such fees, levies, rental or other income received by the Commission from the renting or usage of such facilities or from any activity organized or approved to be undertaken thereon; and

(iii) engage, on such terms as the Commission may determine, any person or contractor to assist the Commission in carrying out its functions as the Managing Agent.

**Revocation**

4. *Gazette* Notification No. *Swk L.N. 92/2011* dated 18th August, 2011 and *Gazette* Notification No. *Swk L.N. 570/2019* dated 26th December, 2019 are hereby revoked.
