THE INTERPRETATION ORDINANCE, 2005

THE FEES (REGISTRATION OF CONTRACTORS AND CONSULTANTS)
ORDER, 2024

(Made under section 54(2))

In exercise of the power conferred by section 54(2) of the Interpretation Ordinance [*Cap. 61*], the Yang di-Pertua Negeri has made the following Order:

Citation and Commencement

1. This Order may be cited as the **Fees (Registration of Contractors and Consultants) Order, 2024**, and shall be deemed to have come into force on the 1st day of January 2024.

Fees chargeable

2. The fees stipulated in the Schedule shall be chargeable for the registration of contractors or consultants, processing of the new application for registration, renewal of registration, re-registration, upgrading of contractors or consultants.

3. All fees chargeable pursuant to this Order shall be made payable to the Government of Sarawak and may be received by the State Financial Secretary or any officer authorised by him to receive the same.
