THE CHARITABLE TRUSTS ORDINANCE, 1994

LEMBAGA AMANAH KEBAJIKAN REJIMEN ASKAR WATANIAH SARAWAK  
(LAKRAWS) DECLARATION, 2023

(Made under section 3(1))

In exercise of the powers conferred by section 3(1) of the Charitable Trusts Ordinance, 1994 [*Cap. 7*], the Yang di-Pertua Negeri has made the following Declaration:

**Short Title**

1. This Declaration may be cited as the **Lembaga Amanah Kebajikan Rejimen Askar Wataniah Sarawak (LAKRAWS) Declaration, 2023**.

**Declaration of Charitable Trust**

2. It is hereby declared that—

(a) The Lembaga Amanah Kebajikan Rejimen Askar Wataniah Sarawak (LAKRAWS) Declaration, 2023 shall be deemed to come into force on the 7th December, 2022.

(b) A Charitable Trust shall be created and be known as the Lembaga Amanah Kebajikan Rejimen Askar Wataniah Sarawak (LAKRAWS).

(c) The trust properties are as described in the First Schedule and shall be administered by a Board of Trustees appointed under section 4 of the Charitable Trusts Ordinance, 1994 [*Cap. 7*], for the benefits of beneficiaries specified in clause 2(d).

(d) The beneficiaries or intended beneficiaries of the said Charitable Trust shall be officers and other ranks in Rejimen Askar Wataniah Sarawak.

(e) The purposes of the Charitable Trust are as set out in the Second Schedule.

*FIRST SCHEDULE*

(Clause 2(c))

TRUST PROPERTIES

(1) LAKRAWS will receive fifteen percents (15%) shares of Borneo Brave Stone Sdn. Bhd. (for free); and

(2) LAKRAWS will receive regular, monthly contributions from Borneo Brave Stone Sdn. Bhd. for the purposes specified in the Second Schedule.

*SECOND SCHEDULE*

(Clause 2(e))

TRUST PURPOSES

(1) To raise, apply, receive and manage any grant, gift, donation, contribution or any other sums for Lembaga Amanah Kebajikan Rejimen Askar Wataniah Sarawak (LAKRAWS) and the wellbeing of the officers and other ranks in Rejimen Askar Wataniah Sarawak; and

(2) Any other charitable purposes which the Board of Trustees considers desirable or expedient from time to time for the benefit of the officers and other ranks in Rejimen Askar Wataniah Sarawak.
