WATER ORDINANCE, 1994

AUTHORIZED PERSONS FOR COMPOUNDING OF OFFENCES ORDER, 2020

(Made under section 46A(1)(b))

In exercise of the powers conferred by section 46A(1)(b) of the Water Ordinance, 1994 [*Cap. 13*] (“the Ordinance”), the State Water Authority has made the following Order:

**Citation and commencement**

1. This Order may be cited as the **Authorized Persons for Compounding of Offences Order, 2020**.

**Authorized persons for compounding of offences**

2. The officers listed in the Schedule shall be the authorized persons for their respective water supply authority to compound offences under the Ordinance.
