THE INTERPRETATION ORDINANCE, 2005

THE MAJLIS MESYUARAT KERAJAAN NEGERI (DELEGATION OF POWERS)
NOTIFICATION, 2021

(Made under section 34)

In exercise of the powers conferred by section 34 of the Interpretation Ordinance, 2015 [*Cap. 61*], the Majlis Mesyuarat Kerajaan Negeri, being responsible to advise the Yang di-Pertua Negeri, has delegated the powers to advise the Yang di-Pertua Negeri on matters related to the Majlis Islam Sarawak Ordinance, 2001 [*Cap. 41*], the Syariah Courts Ordinance, 2001 [*Cap. 42*] and the Islamic Family Law Ordinance, 2001 [*Cap. 43*] as provided in the Schedule, to the Minister charged with Islamic Affairs with effect from the 17th day of December, 2020.
