ORDINANCE, 2013.

THE SPEAKER, DEPUTY SPEAKER AND MEMBERS OF DEWAN UNDANGAN NEGERI
(ALLOWANCES AND BENEFITS) ORDER, 2013.

(Made under section 5)

In exercise of the powers conferred by section 5 of the Members of the Administration and Members of Dewan Undangan Negeri (Remuneration, Pensions and Gratuities) Ordinance, 2013, the Yang di-Pertua Negeri makes the following Order:

Citation and commencement

1.—(1) This Order may be cited as **the Speaker, Deputy Speaker and Members of Dewan Undangan Negeri (Allowances and Benefits) Order, 2013**.

(2) This Order shall come into force on the 1st day of June, 2013.

Allowances and Benefits

2. All allowances and benefits specified in the Schedules shall be payable and provided to the Speaker, Deputy Speaker and Members of Dewan Undangan Negeri.

Revocation

3. All Directions made under section 5 of the Members of the Administration and Members of Dewan Undangan Negeri (Remuneration, Pensions and Gratuities) Ordinance, 1980 are revoked.

(Note: Official Entertainment Allowance is payable in addition to subsistence allowance and payment must be supported by a certificate from the claimant that expenses were incurred on entertaining guests while on government official duties. When no entertaining was involved, only subsistence allowance would be payable.)

- (14) Lodging Allowance (in lieu of Government accommodation)

(Note: Leave may be accumulated for 2 years with prior approval of the Chief Minister.)

(Note: Subject to such terms and conditions as may be determined by the Government from time to time.)

- (17) Medical Facilities
Free medical treatment in First Class Ward (Special Room) at Government Hospital and at Normah Medical Specialist Centre including for his immediate family.

(Note: "Immediate family" means spouse and dependant children.)

- (18) Housing Loan
RM 800,000.00 subject to such terms and conditions as may be determined by the Government from time to time.

- (19) Vehicle Subsidy
RM 30,500.00 subject to such terms and conditions as may be determined by the Government from time to time.

- (20) Computer Loan
RM 5,000.00 or 90% of selling price whichever is the lower and subject to such terms and conditions as may be determined by the Government from time to time.
- (21) Official Car
Type: Mercedes-Benz or equivalent
Price: Not exceeding RM 700,000.00

- (1) Entertainment Allowance
RM 6,000.00 per month
- (2) Launching Allowance (Every appointment)

(Note: Official Entertainment Allowance is payable in addition to subsistence allowance and payment must be supported by a certificate from the claimant that expenses were incurred on entertaining guests while on government official duties. When no entertaining was involved, only subsistence allowance would be payable.)

- (13) **Lodging Allowance (in lieu of Government accommodation)**
(a) Outside Kuching (within Malaysia) (while on official duty)

- (14) **Annual Leave**
30 days.
(Note: Leave may be accumulated for 2 years with prior approval of the Chief Minister.)

- (16) **Medical Facilities**
Free medical treatment in First Class Ward (Special Room) at Government Hospital and at Normah Medical Specialist Centre including for his immediate family.
(Note: "Immediate family" means spouse and dependant children.)
- (17) **Housing Loan**
RM 500,000.00 subject to such terms and conditions as may be determined by the Government from time to time.
- (18) **Vehicle Subsidy**
RM 19,600.00 subject to such terms and conditions as may be determined by the Government from time to time.

RM 200,000.00 subject to such terms and conditions as may be determined by the Government from time to time.
- (10) Hotel Entitlement (while on official duty)
Actual bills with receipts (Standard Room)
- (11) Vehicle Subsidy
RM 12,600.00 subject to such terms and conditions as may be determined by the Government from time to time.
