THE CHARITABLE TRUST ORDINANCE, 1994

THE SARAWAK PRIVATE CHINESE SECONDARY SCHOOLS
CHARITABLE TRUST DECLARATION, 2013

(Made under section 3(1))

In exercise of the powers conferred by section 3(1) of the Charitable Trusts Ordinance, 1994 [*Cap. 7*], the Yang di-Pertua Negeri has made the following Declaration:

Citation and Commencement

1. This Declaration may be cited as the **Sarawak Private Chinese Secondary Schools Charitable Trust Declaration, 2013** and shall be deemed to have come into force on the 1st day of September, 2013.

Declaration of Charitable Trust

2. It is hereby declared that—

(a) a Charitable Trust shall be constituted and be known as the Sarawak Private Chinese Secondary Schools Charitable Trust;

(b) the properties described in the First Schedule shall be administered by a Board of Trustees appointed under section 4 of the Charitable Trusts Ordinance, 1994 [Cap. 7];

(c) the beneficiaries of the Charitable Trust shall be all Private Chinese Secondary Schools in Sarawak registered under the Education Act, 1996 and any persons, bodies or institutions whom the Board of Trustees determines shall be eligible for financial assistance or support from the Trust due to:

(i) the similarity of their charitable works, causes or objects with the Trust Purposes in the Second Schedule;

(ii) reasons of poverty and financial or other circumstances require assistance from the Trust to pursue or continue with their studies in any of the aforementioned Schools; and

(d) the purposes of the Charitable Trust are set out in the Second Schedule.

FIRST SCHEDULE

(Paragraph 2(b))

TRUST PROPERTIES

1. Any property, moveable or immovable, which have been or shall be vested, bequeathed or pledged for the Charitable Trust purposes stipulated under the Second Schedule.

2. Contributions, donations and gifts from any Government, institutions, corporations and any other persons or individuals or sources for purpose of the Charitable Trust, including any legacies and properties bequeathed by will or other instruments for the Charitable Trust purposes set out in the Second Schedule.

3. Land, buildings and any other properties or assets, movable and immovable, including moneys, bonds and shares acquired or held or controlled for the purposes of Charitable Trust.

SECOND SCHEDULE

(Paragraph 2(d))

TRUST PURPOSE

1. To promote and sustain education in Private Chinese Secondary Schools in Sarawak which are registered under the Education Act, 1996.
2. To enhance or improve or adequately maintain facilities, amenities and premises in the said Schools so as to provide quality education for all students in these Schools.
3. To provide financial assistance to students in the said Schools who are in need of such assistance in order to pursue or continue their education in these Schools.
4. To make donation, contribution or support financially or otherwise to other charitable bodies or institutions whose charitable works or causes are identical or similar to those set out above.
